2026 GOLF LEAGUE AGREEMENT

We will attempt to be as close as possible to the requested time.

The above league guarantees to submit to the following rules and regulations:

- 1. The greens fee per nine-hole round will be \$25.00**
 - Note: Cart fees are \$15 for 9 holes
- 2. League Deposit Fee is \$500**
 - League deposit dues will be required after the completion and approval of registration.
- 3. Full league payment will be required by each individual player before the start of the league.**
 - Depending on the length of each league, each individual will be required to choose a pass:
 - Walking League Pass (Total Greens Fee Only)
 - Walkers have the option to add a cart if they wish too on each match day upon arrival for check-in.
 - Riding League Pass (Total Greens Fee + Total Cart Fee)
- 4. Flex League Scheduling:**
 - Leagues will be scheduled from Monday - Thursday.
 - As the year goes on starting times will flex based on sunset.
 - The last tee time for a group will be no less than 2 hours and 15 minutes until sunset.
 - This means your leagues first starting time will also move back later in the day to accommodate the influx of play during the day in the summer months.
- 5. The League season will run from Monday March 30th to Friday October 30th**
 - You can book your league for any length of time (16 weeks minimum) inside of this window.
 - This includes any practice rounds you would like to schedule.
 - Weather postponements will be rescheduled to dates later in the league season, otherwise we will schedule to fit them in a time that works for all parties.

- There will be no league matches scheduled on Holidays unless approved by the staff.

6. League playoffs will need to be scheduled to finish by Friday October 31st.
7. One person shall be appointed as a liaison between league and management.
8. In case of tardiness, starting times will be forfeited.
9. Local and USGA Rules are to apply.
10. Management reserves the right to terminate this agreement if participation in the league is less than 80% of the number of players indicated above.

***League Rules may be subject to change prior to the start of the season.**
